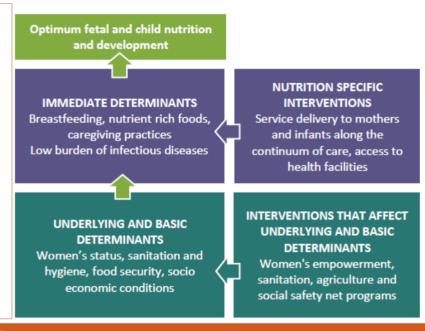

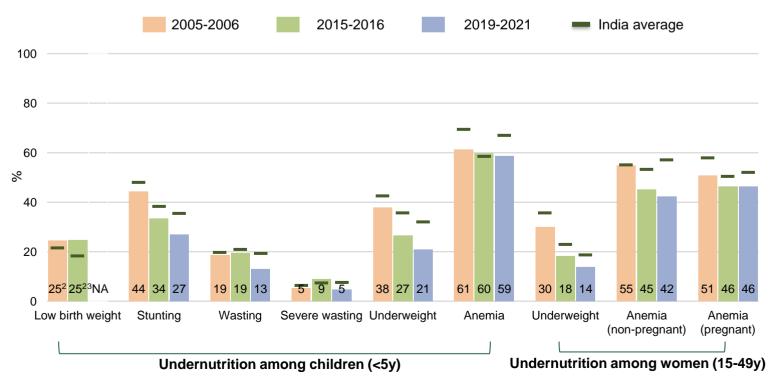
### State Nutrition Profile: Uttarakhand

#### **ABOUT THIS DATA NOTE**

This Data Note describes the trends for a set of key nutrition and health outcomes, determinants, and coverage of interventions. The findings are based on estimates using unit-level data, data from national and state reports from the National Family Health Survey (NFHS)-3 (2005-2006) and NFHS-4 (2015-2016), and data from state factsheets and reports from NFHS-5 (2019-2021). In addition to standard prevalence-based analyses, this Data Note includes headcount-based analyses aligned to the POSHAN Abhiyaan monitoring framework to provide evidence that helps identify priority districts and number of districts in the state with public health concern as per the WHO guidelines. 1 The Data Note includes a color-coded dashboard to compare the coverage of nutrition interventions across all the districts in the state. It concludes with key takeaways for children, women, and men, and identifies areas where the state has potential to improve.



# Figure 1. Trends in undernutrition outcomes 2005-2006, 2015-2016, 2019-2021



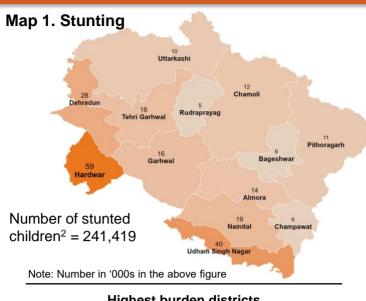

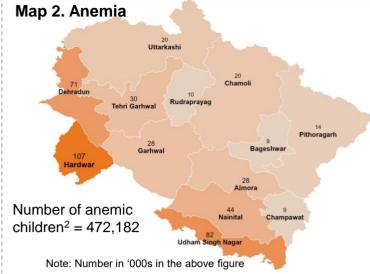

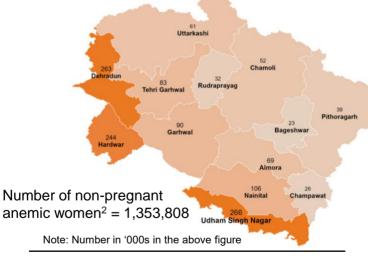

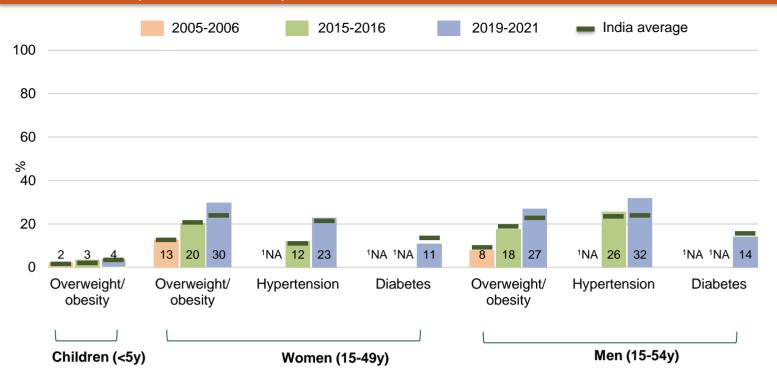
### Map 8. Anemia among pregnant women<sup>3</sup>

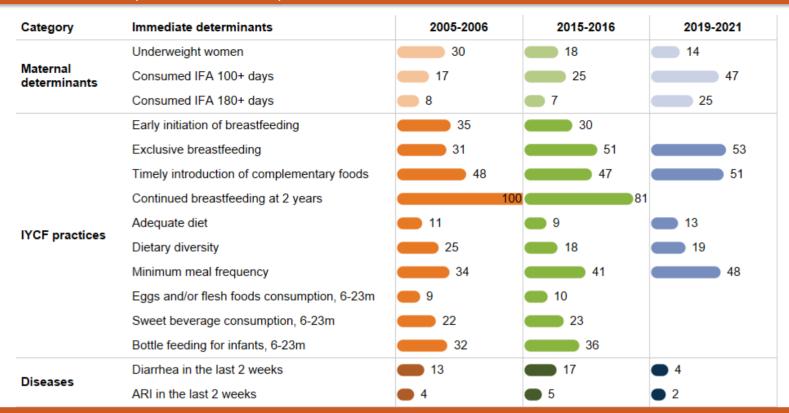

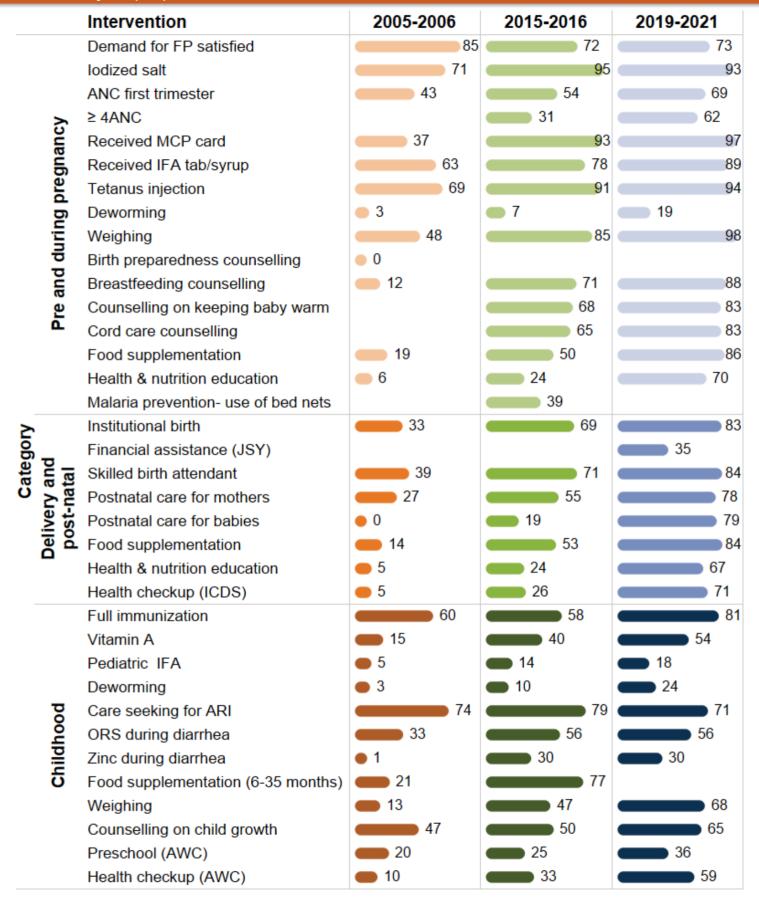

### Key takeaways

Children: Stunting and underweight prevalence declined by 10 percentage points (pp) and 11pp between 2006 and 2016 and by 7pp and 6pp between 2016 and 2021, respectively. Wasting remained stable between 2006 and 2016 before declining by 6pp between 2016 and 2021. Anemia slightly declined by 1pp between 2006 and 2016 and between 2016 and 2021. Overweight/obesity increased by 1pp between 2006 and 2016 and between 2016 and 2021.

**Women**: Underweight declined by 12pp between 2006 and 2016 and by 4pp between 2016 and 2021. Anemia among non-pregnant and pregnant women declined by 10pp and 5pp, respectively, between 2006 and 2016; anemia among non-pregnant women continued to decline by 3pp but remained stable among pregnant women between 2016 and 2021. Overweight/obesity prevalence increased by 7pp between 2006 and 2016 and by 10pp between 2016 and 2021.

Men: Overweight/obesity increased by 9-10pp between 2006 and 2016 and between 2016 and 2021.

Attention is needed to improve (%s in 2021):

diarrhea

- Outcomes: Stunting (27%), anemia in children (59%); anemia (42-46%) and overweight/obesity (30%) in women
- Immediate determinants: 180+ IFA (25%); adequate diet (13%), dietary diversity (19%)
- *Underlying determinants:* Women with ≥10 years education (50%)
- Coverage of interventions: Deworming-women and children (19-24%); financial assistance-JSY (35%); vitamin A supplementation (54%); pediatric IFA (18%); zinc during diarrhea (30%); preschool-AWC (36%)
