Kindly refer to Secretary (Expenditure) & Finance Secretary's DO letter no. 12(2)/E.Coord/2021 dated 05.02.2021 regarding clearance of outstanding C&AG and PAC paragraphs against your Ministry/Department in compliance with PAC/CoS directives.

- 2. The meeting of Committee of Secretaries (CoS) chaired by Cabinet Secretary to review pendency of Action Taken Notes on C&AG Audit paras/PAC recommendations was held on 21.07.2017. The CoS had directed that the pendency should be reduced to zero by 31.12.2017. However, the targets set by CoS have not been achieved fully by Ministries/Departments despite regular pursing of the matter at different levels by this Department.
- 3. Time to time PAC has also expressed serious concern on non-submission of ATNs/ATRs on C&AG/PAC paragraphs within the prescribed time limit of 04 months/06 months respectively and directed to take remedial steps to ensure compliance. I am constrained to state that Ministries/Departments are still not adhering to the timelines prescribed for the submission of ATNs/ATRs.
- As on 21.11.2021, as per the Audit Para Monitoring System (APMS) portal, 1290 C&AG paras & 280 PAC paras are pending against various Ministries/Departments for submission of ATNs/ATRs (copy enclosed).
- 5. Therefore, I request you to personally look into the matter to expedite the clearance of outstanding C&AG & PAC paragraphs against your Ministry/Department in compliance with the PAC/CoS directives.
