### **OTHER TERMS AND CONDITIONS:**

1. Applicant must be Citizen of India.
2. Candidates must carefully read instruction/eligibility criteria before filling-up/submission of application.
3. The appointment on Contract/Deputation will be initially for a period of 03 (Three) years and further extendable upto two years depending upon performance but not exceeding beyond the age of Sixty years.
4. The terms and conditions for appointment on deputation basis will be regulated as per DoP&T/Govt. of India orders and guidelines issued from time to time.
5. The terms and conditions for appointment against reservation (SC, ST, OBC and EWS) will be regulated as per DoP&T/Govt. of India orders and guidelines issued from time to time.
6. The candidates seeking reservation under SC/ST/OBC shall be required to enclose attested copies of caste certificate issued by the appropriate authority in prescribed format, in support of their claim.
7. The candidate seeking reservation under EWS shall be required to provide documents as per the norms prescribed by the Govt. of India.
8. Relaxation in age to deserving candidates will be considered as per rules and discretion of the Competent Authority.
9. On appointment, the contractual employees will not be entitled to benefits like gratuity, leave encashment, CPF/NPS, official transport etc. The terms and conditions for appointment on deputation will however be regulated as per DoPT/Govt. of India order and guidelines issued from time to time.

12. For the post of Joint Director, preference will be given to the candidates who have experience in preparing research proposals, getting research projects through bidding process and generating revenues from research and training assignments/activities independently.

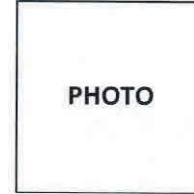
